2. Pedagogical Approaches

At St Francis all learning is based on the Victorian Curriculum covering eight domains and consists of integrating all learning through an Inquiry/Investigation Learning Approach.

Our curriculum encompasses Religious Education with faith development, Christian Praxis, scripture knowledge, and social justice incorporated in all areas of school life.

Our literacy and numeracy program emphasises explicit and focused teaching using information gained from ongoing assessment and data analysis. Planning, data analysis, and intervention responses are supported by expert Literacy and Numeracy Coaches.

As a school community, we are committed to meeting the individual learning needs of each student. Through data analysis, professional learning community dialogue, and support from expert coaches, student needs are identified, investigated, and responded to in a culture of co-accountability and responsibility for all students. St Francis promotes 'in the moment' intervention through focused teaching groups by both curriculum coaches and classroom teachers. We also provide Reading Recovery and EMU as a Tier 1 intervention in the Junior School.

St Francis employs the services of a Speech Pathologist and Occupational Therapist to support students. This is an educational model and it is supported by Education Support Officers.

Students participate in Visual Arts, Performing Arts, Physical Education, L.O.T.E (Indonesian), Social and Emotional Learning, and Digital Technology through our Specialist programs.

3. Curriculum Planning and Review

St Francis schools use *Victorian Curriculum* and *The Source of Life* to inform both teaching and reporting.

All teaching staff are allocated the appropriate non-face-to-face scheduled teaching time release and classroom teachers are expected to plan together to ensure consistent delivery of the curriculum. In addition to this, each year level has a day at the end of each term to plan for the following term, attending to and documenting the curriculum outcomes. Planning is supported by expert Coaches in the key Curriculum areas of Literacy, Numeracy, and Catholic Identity.

Planning documentation reflects the outcomes of the Victorian Curriculum, as does the *End of Semester Reports* where progress is measured against appropriate progression points.

Each Learning Community participates in a weekly Professional Learning Community (PLC) meeting. St Francis uses the PLC model of 'Learn / Do' to allow time to learn together and implement and analyze new learning. This model provides the opportunity for staff to review student data and reflect on the effectiveness of pedagogy and plan for future implementation. The Curriculum Coaches and the Learning Diversity Leader work together to ensure individual learning needs are catered for.

The students work in a variety of learning environments:

- Cross-age (through a buddy system)
- Mixed ability
- Needs-based
- Co-operative groups
- Whole-Class

At St Francis we are consistently reviewing and evaluating current practice in light of student outcomes and teacher confidence through our Assessment Schedule, student voice surveys, and Coaching strategy. All teaching staff are required to set goals for professional growth and are accountable to their Community Leader during termly meetings.

Assessment at St Francis is ongoing and formative. Teachers design pre and post-assessment in many curriculum areas and commit to responding to student learning in a timely and abundant manner. This includes feedback for current learning and feed forward of future learning.

Formative Assessment tasks are developed by teachers working together with the curriculum coach to ensure consistency across classes, ease of moderation, and co-accountability and responsibility for all children in the cohort.
